Summary Annual Report

This is a summary of the annual report of the Holland Enterprises, LLC, EIN 450419854, Plan HOLLAND ENTERPRISES, LLC HEALTH AND WELFARE BENEFIT PLAN, Plan No. 506, a welfare benefit plan, for period April 01, 2024 through March 31, 2025. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

All components of the plan other than the Health FSA component are provided through insurance contract(s).

Holland Enterprises, LLC has committed itself to pay certain Health claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with FIDELITY SECURITY LIFE INSURANCE COMPANY and Standard Insurance Company to pay Life Insurance, Death Benefits (ACCIDENTAL DEATH & DISMEMBERMENT), Vision, Dental incurred under the terms of the plan. The total premiums paid for the plan year ending March 31, 2025 were \$241,668.00.

Because they are so called “experience-rated” contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending March 31, 2025, the premiums paid under such “experience-rated” contracts were \$206,226.00 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$102,366.00.
