IT'S TIME TO ENROLL!

2025 OPEN ENROLLMENT DATES

OCTOBER 21— NOVEMBER 8, 2024

Open Enrollment for the 2025 benefit plan year (January 1, 2025 - December 31, 2025) is almost here!

Open Enrollment Reminders

This is your annual opportunity to make changes to your benefits. This includes:

- Add, cancel, or change your coverage
- Add or remove eligible family members
- Enroll or re-enroll in the Health Care Flexible Spending Account (FSA) and/or Dependent Care Flexible
 Spending Accounts (DCFSA) You must re-elect contributions annually; current elections will not rollover into 2025
- Once the Open Enrollment window closes, you will be unable to make changes to your 2025 elections without a Qualifying Life Event (QLE)

How to Enroll:

- 1. Access the Paylocity login page https://access.paylocity.com/ (Chrome browser recommended)
- 2. Once logged in, select the 3 line icon located in the top left corner of the screen
- 3. Scroll down and select Bswift Benefits
- 4. Hit the **orange** Start Your Enrollment button and make your benefit elections
- 5. Or, you can call the Benefits Enrollment Center 7AM 5PM CST, Monday Friday at:
 - 1-888-598-2040 and a Benefit Specialist will assist you with making your elections

Dependent Verification Audit:

Starting in 2025, we will be conducting a dependent verification audit. This audit will ensure only <u>eligible</u> dependents are covered under our benefits plan(s). Eligible dependents include:

- Your spouse (wife or husband by a legally valid marriage)
- You or your spouse's biological or adopted child(ren), or
- A child for who you have legal guardianship or a similar arrangement that confers authority to care for the person and property of the child under applicable law

If you currently have any dependent(s) covered under one or more of our plans that do not meet the definitions outlined above, please drop them from coverage during Open Enrollment

Failure to drop coverage for an ineligible dependent(s) will result in immediate termination of benefits and require you to pay back premiums for the month(s) you had an ineligible dependent(s) covered under our plan(s).

WHAT'S NEW IN 2025

Disability Contributions Pre or Post Tax Options:

Trinidad Benham is offering employees the choice to have their LTD benefit paid on a pre or post tax basis. If you do not make a selection, the default option will be a taxable LTD benefit. Please make sure to update your preference during **Open Enrollment.**

Here are your options:

- Post-tax benefit payment (default): Trinidad pays 100% of the LTD premium on your behalf and you are not taxed on the premium paid. Benefit paid at time of claim would be 100% taxable to you
- Pre-tax benefit payment: Trinidad pays 100% of the LTD premium on your behalf and you pay the tax on the LTD premium. Benefit paid at time of claim would be tax-free to you
